### **Procedure for making ONLINE Payment**

- Student has to Login to the website of University of Madras and Click Online Payment Link
- Student has to enter his / her Enrolment Number
- Student's detail with Fees payable will be displayed
- Student has to submit and select Indian Bank in the next screen
- Student has to select either (a) Generate Challan for Indian Bank Net Banking / Counter payment OR (b) Other Bank Net Banking / Debit / Credit Card.
- If option (a) is selected, Student details with Bank Reference Number will be displayed.
