All items are required to be supplied CAPC& Mid Corporate Branch at F.Floor, Gee Gee Complex, No.:42, Annasalai, Chennai-02 . The suppliers will be responsible for delivery of goods in good condition at their own risk and cost. No cartage charges

Special Conditions

- 1. The supplier shall sign each page of this tender and quote their price for all the items without any omission.
- 2. The rates to be quoted shall include the transportation and all other applicable taxes and nothing extra would be paid on whatsoever ground except GST.
- 3. The material shall be as per specified in the schedule and leaflet/brochure of the same shall be given along with the offer
- 4. Supplier has to be quoted for the approved specifications/materials only. Other than that it will not be considered.
- 5. The Light fitting shall be supplied with all accessories such as clamps, Screws and leads of standard length for connection etc and complete as required for fixing of the fittings /fixture.
- 6. The items shall be supplied within 10 days from the date of order.
- 7. Liquidity Damage @ 1% of delayed supply per 3 days of supply of material subject to maximum up to 10% of delayed supply to be deducted.
- 8. The rates quoted by the supplier shall be firm throughout the duration of contract (including extension of time if any granted) and will not be subject to any fluctuation due to variation-in cost of material and labour.
- 9. The quote shall be valid for min. Three (3) months from the date of opening of bid
- 10. Any addition, alteration or correction in the quote shall be signed and stamped properly by the contractor
- 11. Conditional quotes and Incomplete /quotations are liable to be rejected.
- 12. Supplier has to submit the proper accounting statement for payment of GST while submit the final bills.



13. Payment Terms

No advance payment shall be made to the supplier for supply of any material supplied at site for execution. Payment shall be made upon Testing & commissioning of fixtures/ fitting by bank.

95% payment on satisfactory Testing & commissioning of fixtures/ fitting by bank with 5% of the total bill value excluding Tax will be retained for performance guarantee for a period of 1 year from the date of Testing & commissioning.

In case, If there is delay in Testing & Commissioning of fixtures/ fitting by bank more than 10 days from the date of supply of materials at site, the supplier is eligible for 60% of the total cost of material supplied (Fixture/Fitting) after providing suitable GST invoice.

The retention amount will be refunded to the suppliers 14 days after the end of defect liability period provided they have satisfactorily carried out all the work and attended to all defects in accordance with the condition of the contract. No interest is allowed on retention money.

- 14. The supplied materials should have a warranty of minimum one year and the same shall be clearly indicated in the offer.
- 15. The quantities mentioned in schedule are provisional and likely to increase /decrease to any extent or may be omitted thus altering the aggregate value of the contract. No claim for loss of profit/business shall be entertained on this account.
- 16. Payment to the supplier shall be made as per actual work done of site.
- 17. The Bank reserves the right to accept/reject any quotes without assigning any reasons.
- 18. The supplied items are found defective, the same should be replaced within a period of 2 days.
- 19. It may please be noted that the bank is not bound to allot the work to the lowest
- 20. The supplier shall not directly or indirectly sublet the work to other party without written permission of the bank.
- 21. The quotations will be opened in the presence of the participating bidders or their authorized representatives, who may like to be present at the time of opening the Quotations.
