Instructions for filling up Financial bid

- a) Bidders have to submit the price bid in the standard format only provided by the Bank. Bank reserves the right to reject the bids which have not been submitted in the standard price bid format.
- b) There will not be any change in the rate agreed upon. However Bank will reimburse to the PSA the net impact due to increase in minimum wages and / or Dearness Allowance by the Government of India on submission of claim with documentary proof.
- c) Monthly wages to be arrived at as per provisions of the latest Central Govt. notification on Minimum Wages for respective area. The minimum rate of wages includes the wages for weekly day of rest also. Hence monthly basic wages plus variable Dearness Allowance (VDA) will be calculated on 26 days as per prevailing Act and Rules.
- d) All statutory and social security obligations like, EPF, ESI, Bonus etc. at applicable rates at present are to be necessarily added. Price bids without the above statutory and social security obligations or with incorrect provisions are liable to be rejected. It is the contractor's responsibility to ensure that all statutory payments and wages as per Central minimum wages are paid to the security guards.
- e) Service Charges must include Uniform / Maintenance. It is the contractor's responsibility to ensure that guards are provided with proper uniform and are properly turned out for duty.
- f) Contractor has to ensure that Guards carrying out Reliever duty are paid minimum wages as applicable and the same is to be included in the monthly wages.
- g) The breakup for the wages furnished in the financial bid should be mentioned by the bidders along with price bid The details of minimum wages and other statutory payments are enclosed in the bid documents except that of Service charges of the Private Security Agency.
- h) GST will be extra at applicable rates.
