- The machine cost shall include loading, unloading, transportation charges etc. Free delivery without any extra charges shall be made to our Branch at Visakhapatnam.
- BEE certified 3 star rating wall split unit as described above with cordless remote split type air conditioner unit each comprising of an outdoor unit and single hi wall mounted indoor unit with gas filling as required including mounting the indoor unit, making interconnections with refrigerant piping and control wiring, installation of ODU in cage / stand etc. Condenser unit shall be complete with hermetically sealed scroll, reciprocating, rotary compressor and air cooled condenser with fan evaporating units shall consist of a fan section with dynamically balanced centrifugal fan driven by FHP motor, multi row deep cooling coil of copper tube with aluminium fins, thermostatic expansion valve etc. the evaporating unit shall be equipped with synthetic fiber filter, insulated drain pan safety single phase units. Suitable for operation on 230 V, 50 Hz Single phase, A.C. power supply capable of performing; Cooling, Dehumidifying, Air Circulating & Filtering. The condenser fan and indoor unit blower fan should have copper winding.

- Supply and laying of copper refrigerant piping (liquid and gas) of size as per manufacturers specifications with 19/20 mm nitrile rubber insulation with all accessories such as bends, elbows, unions, etc., brazing/soldering, clamping/binding with suitable tie knots, providing insulation with suitable material as per latest industry standard etc.
- The machine cost should be inclusive of 3 running meter of Copper pipe, Electrical cable, and PVC Drain pipe.
- AC machine coil must be copper made and fins can be Aluminium with rust proof coating
- The new AC will be covered under minimum 1 year comprehensive warranty from the date of installation. Fixed speed compressor warranty will be 5 Years
- Copper pipe should be 20 gauge copper tube (combined for suction and liquid line) with Nitrile insulation 19/20 mm and adhesive tape with proper saddling works. Make: Kobe, Mandev, Met, Nissan, Rajco or approved during pre-bid.
- Electrical cable / communication cable with termination- Three/Four core cable 2.5sqmm copper stranded. Make: Havels, Finolex, KEI or as approved during pre-bid.
- UPVC Drain pipe (insulated) Single unit 25mm, Two or more units 32mm/40mm with saddling, connectors, unions, T joint, L bend etc. Joints must be sealed with proper adhesive. Make Prince, finolex or approved during pre-bid.
- Stabilizer It recognizes the voltage fluctuations in the circuit and regulates it internally to deliver a consistent range of output voltage. If voltage is low; the stabilizer senses it, boosts it to the required level of voltage and then feeds to the connected AC to work without trouble. This happens vice versa in case of a high voltage that appears in the utility line. The overload protection feature turns off the stabilizer output completely in case of short circuit or any kind of burn-out due to overload occurs. Make V-Guard, Microtek or approved brand by Bank.
- All the above AC units shall be filled with R-410A, R-32 or any other eco-friendly refrigerant. Refrigerant R-22 is not acceptable.
- Apart from the above, if any additional work is involved during the installation of new AC units, the contractors/Authorized dealer shall obtain the prior approval from Bank carrying out the same.
- Supply, fabrication and installation of MS base frame for indoor & outdoor units complete with epoxy painting, vibration isolation pads, supports, hangers, railing, brackets etc. For construction as approved by Bank. For fabricated MS frame- apply 2 coats of epoxy primer 2 coats of epoxy paint and finish painting as approved by Bank. Outdoor unit Stand to be made as per site conditions.

#### INDEMNITY CLAUSE: (To be submitted on bidder's letter head)

The firm shall indemnify the Bank against all actions, suits, claims and demands brought or made against it in respect of anything done or committed to be done by The firm in execution of or in connection with the work of this contract and against any loss or damage to the Bank in consequence to any action or suit being brought against the firm for anything done or committed to be done in the execution of this contract. The firm will abide by the job, safety measures prevalent in India and will free the Bank from all demands or responsibilities arising from accidents or loss of life, the cause of which is the firm's negligence. The firm will pay all indemnities arising from such incidents, without any extra cost to Bank and will not hold the Bank responsible or obligated.
