TERMS AND CONDITIONS

1. Tender should be filled only in the Tender Forms prescribed by the Bank and the same can be obtained from Zonal Office Udaipur: Security Department. Also the application form can be downloaded from www.indianbank.co.in. The bidders have to enclose the application fee of Rs.200/- (Non Refundable) along with their EMD with separate Demand Drafts for each form submitted.
2. The Sealed tenders can either be deposited in the Tender Box kept in the Bank's Zonal Office or be sent by post. Tenders received by post will be considered only if the same is received by the Bank within the stipulated time / date as given in the Tender Notice and the date of posting shall not be considered as date of receipt of tender form.
3. Along with each tender earnest money of Rs. 5000/- shall be remitted by means of Demand Draft / Banker's Pay Order favouring Indian Bank. The Demand Draft / Pay Order shall not be dated earlier than the tender notice and shall be payable at Udaipur only. Money Orders/Cash/Postal Orders, Bank Guarantees cheques etc. shall not be accepted in lieu of Demand Draft / Pay Order
4. Conditional tenders, late submitted tenders and tenders without EMD will be rejected.
5. The bidders or their representative (not more than one) may be present, if they so desire, at the time of opening of offer / price bid.
6. The successful bidder will be required to deposit the balance bid amount after deducting earnest money within 10 days by demand draft / IOI in favour of "Indian Bank" payable at Udaipur.
If the H1 bidder did not honour the offer letter of the bank or did not remit the balance amount or refused to pay the balance amount within the stipulated time, Bank reserves the right to forfeit the EMD amount of the H1 bidder. In such case, Bank may offer the disposal of vehicle to H2 bidder for purchase at H1 rate. If H2 bidder refuses to purchase, the offer will be given to H3 bidder for purchase of vehicle at H1 rate. Hence, the EMD of H1, H2 & H3 bidder's will be withheld by bank till the H1 bidder remits the balance amount & complete the sale formalities
7. The delivery of the sold vehicle will be given only after the verification of KYC documents by Bank.
8. The sold vehicle shall have to be removed by successful bidder at his own expenses.
9. The vehicle will be disposed off as it where is and whatever basis.
10. The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own expenses. The Bank will not be responsible for any lapses on his part in this regard.
11. The successful bidder cannot withdraw bid, failing to which earnest money will be forfeited.
12. The Bank reserves the right to accept or reject any/all of the offer/price bid without assigning any reason.
13. Approval of sale offer is subject to Bank's internal procedure and as such participating bidders has no right to claim interest on the earnest money deposited by them with the Bid/Quotations/ sale offers.
14. No Intermediaries or Brokers are allowed in the Bids.
15. The quoted price will be excluding the applicable GST. GST applicable will be paid by the successful bidder to the Indian Bank for onward submission to the Govt. of India.
