The requirement is of Sealed Maintenance Free (SMF), valve regulated Lead Acid Batteries (greater than or equal to 12 V) with uniform 65 AH rating from reputed, well-known Indian Manufacturer (Exide/Amaron).

Warranty & Services: Minimum 2 years onsite replacement warranty from the date of installation. Services will be provided by the vendor itself not by any other party.

Delivery & Installation: Delivery and installation/commissioning should be made within Seven (07) days from issuance of the Purchase Order. Installation includes necessary connection of the batteries with the UPS along with connector/cable etc and no separate charge will be paid for this by the Bank. If the vendor fails to deliver and/or install the batteries within mentioned timeline i.e. Seven (07) Days, bank will have the discretion to cancel or nullify the purchase order to L1 and same may be awarded to other vendor who agreed to L1 rates.
