Nature/ Scope of Work in Branch:

The Stand Alone Burglar Alarm System - Digital (Key less) with preset timings for changeover from day to Night mode and vice versa to be installed inside strong Room with Passive Infra Red Sensors (Two)- one inside and one outside Strong Rooms. Electronic Sirens Two connected to the Stand Alone Burglar Alarm System to be installed inside and outside Branch Premises. GSM (SIM based) Auto Dialler to be connected to Stand Alone BAS in close proximity to Stand Alone BAS control Panel inside Strong Room. Vibration Sensors to be installed in adjoining wall installed with Strong Room Door and /or Walls exposed to the outer periphery of the premises. Magnetic Sensors on outer Door of Cash/ Jewel Safe fascia and One IP based HD camera with inbuilt 62 GB memory card inside Strong Room.
2. Electrical power supply to all security items shall be routed through Branch UPS only.
