Bank will not be responsible for any delay caused by postal/courier services. Bids received after prescribed date/time will not be accepted. The successful bidder (H1) after receiving offer letter from this office should deposit the balance amount within 7 days of receipt of the letter failing which the earnest moneys deposit (EMD) will be forfeited and the vehicle will be offered sequentially to H-2 Bidder & H-3 Bidders to purchase on the price quoted by the H-1 Bidder. The applicable GST (12%) rates will be applied on the bid amount. EMD will be returned un-auctioned to all unsuccessful bidders.
