- 2. <u>Term and Condition</u>:- *The Firm shall maintain the Burglar/Fire/ Integrated alarm systems ar ensure that it works as per the parameters of tender.
- 1. *All small and minor parts to be repaired / replaced without claiming extra charges (Major parts suc as Control Panel, Sensors, Hooters, Battery are excluded).
- 2. *The Firm shall inspect the equipment at least once in a quarter as a part of preventive maintenanc This is apart from any breakdown visits that may be required which may emanate in between the tw preventive maintenance inspections.
- 4. *All break downs / faults in systems will be attended immediately within 48 hours and No Exti payment will be made for such break down calls.
- 5. *AMC of Burglar/Fire/ Integrated alarm systems which are under warranty period are not covered above AMC but system will serviced / visited as per scheduled
- 6. *In case of system is required to be taken to the workshop for major repair, a spare serviceable unit the provided and installed and should be function until the original unit is replaced.
- 7. *The firm should have adequate technician and well equipped service cities of Jabalpur and /or othe cities of Madhya Pradesh to attend breakdown call in shortest possible time, the addressed of the service centre provided by the firm will be verified by the Bank.
- 8. *If the services provided by the firm is found to be unsatisfactory or if at any point of time during the contract it is found that the information provided by firm is false, the Bank reserves the right in terminate the contract.
- 9. *The parts of Burglar/Fire/ Integrated alarm systems supplied will carry a free replacement warran of one year.
- 10. *Only authorized technician / service engineer/s with valid ID cards issued by the firm will visit th branch/es.
- 11. *Any dispute other than laid down terms & conditions will be resolved with mutual consent but th decision of Indian Bank will be last and final.
- 12. *A penalty of Rs. 200/- per branch will be levied in case of mandatory quarterly visit not done.
- 13. *The Annual Maintenance Charges shall be paid once in every half year subject to satisfactor maintenance for the period of previous two quarters and on production of service reports duly seale & signed by branch official of each quarter by 15th of the succeeding month. Wherever, the half year visit has not been made, the Branch will deduct half amount of the AMC rate.

3. **BIDDING PROCESS:**

The bidders are required to the Bids in **two separate sealed envelopes**. The First envelop supers cribbed as **"Technical Bid"**, will contain the documents in support of eligibilit criteria and other required documents except Price Schedule. Second envelop super cribbed as **"Commercial Bid"**, will only contain the Quoted Prices, strictly as per th format of Price schedule (Annexure-I). Technical Bid containing any quoted pric information will be out rightly rejected.

4. <u>PERFORMANCE SECURITY</u>:

The Bidder shall have to furnish a security in the form of a Bank Guarantee,

issued by a Scheduled Commercial bank located in India, valid for a period of 1 year +30 days from the Date of Notification of Award of the value equivalent to 10% of the AMC Value.

The security is required to protect the Purchaser against risk of Bidder's conduct, which would warrant the security's forfeiture, pursuant to non-compliance of the purchase order or any term of this RFP.

5. PERIOD OF VALIDITY OF BIDS:

The Bids Offer should remain valid for a period of 5 days from the date of commencement of RFP.

6. PAYMENT TERMS:

Payment will be released on half yearly *basis* (deferred mode) by branches on submission of Invoice, Call reports, PM reports and Satisfaction Letter.

7. <u>PRICES</u>:

9.1 The prices once offered must remain firm and must not be subject to escalation during entire contract period due to fluctuation in foreign currency or change in the duty/tax structure or for any other reason. However, the entire benefits/advantages arising out of fall in prices, taxes, duties or any other reason, must be passed on to the Purchaser without the Purchaser specifically asking for it.

8. TAXES AND DUTIES:

- The Vendor will be entirely responsible to pay all taxes including corporate tax and income tax, duties, license fees, road permits etc. in connection with delivery of goods at site including incidental services and commissioning.
- Sales Tax/VAT and other taxes which will be applicable on the finished goods, should be clearly mentioned separately which will be paid by the Bank on actual basis on production of proof.

9. AGREEMENT CANCELLATIONS:

The Purchaser reserves the right to cancel the agreement in the event of one or more of the following circumstances -





- Abnormal Delay in services.
- Breach by the Vendor of any of the terms & conditions of the tender.
- If the vendor goes into liquidation voluntarily or otherwise.

* Any change in corporate policy regarding AMC of hardware, we may cancel the contract with proper notice.
