### Stage 2:

Qualified bidder shall participate in the online e-Auction for the purchase of old cash van which they wish to purchase.

**TERMS AND CONDITIONS FOR SALE OF OLD CASH VAN**

1. The disposal of vehicle shall be strictly on “**AS IS WHERE IS AND WHATEVER IS BASIS**” and no guarantee or certificate of its worthiness or quality will be given by the Bank. The condition of the vehicle can be inspected physically between 1100 hrs to 1500 hrs on any working day between 29.03.2023 to 12.04.2023 at **Indian Bank, Kaloor Branch, Express Building, Kaloor.**
  2. Bidders need to submit **earnest money for Rs. 5,000/- and application fee Rs 100/-**. The earnest money and Application fee is to be submitted as DD payable at Indian bank, Ernakulam. If the highest Bidder/ successful Bidder fails to deposit the sale price within the prescribed time limit, his earnest money will be forfeited. In case the offer is withdrawn by any Auctioner, the earnest money deposited by him shall be forfeited. Offers received without EMD amount shall not be considered at all by Bank.
  3. The successful bidder will be required to deposit the total bid amount within **seven working days** after receiving letter from the Bank in this regard.
  4. EMD of the successful bidder(s) will be released only after realization of sale proceeds and transfer of ownership of vehicle.
