Stage 2:

Qualified bidder shall participate in the online e-Auction for the purchase of old cash van which they wish to purchase.

Important Conditions of the Auction:

- 1. Application Fee payment details for Rs 100/- (Rupees One Hundred Only); DD Payable at Dehradun
- 2. The EMD Payment details for Rs 5000/-(Rupees Five thousand only) **DD Payable at Dehradun**

TERMS AND CONDITIONS FOR SALE OF OLD CASH VAN

- 1. The disposal of vehicle shall be strictly on "AS IS WHERE IS AND WHATEVER IS BASIS" and no guarantee or certificate of its worthiness or quality will be given by the Bank. The condition of the vehicle can be inspected physically between 1100 hrs to 1700 hrs on any working day between 19.08.2023 to 01.09.2023 at Indian Bank, Kashipur Sadhana Complex Ramnagar Road Kashipur, 244713.
- 2. Bidders need to submit **earnest money for Rs. 5,000/- and application fee Rs 100/-**. The earnest money and Application fee is to be submitted as DD payable at Indian bank, Dehradun. If the highest Bidder/ successful Bidder fails to deposit the sale price within the prescribed time limit, his earnest money will be forfeited. In case the offer is withdrawn by any Auctioneer, the earnest money deposited by him shall be forfeited. Offers received without EMD amount shall not be considered at all by Bank.
- 3. The successful bidder will be required to deposit the total bid amount within **seven working days** after receiving letter from the Bank in this regard.
