## **Terms and Conditions**

1. The contract is for a period of 36 months from 01/05/2024 to 30/04/2027 and the Empanelled contractor shall bound to carry out minimum of one routine maintenance services per quarter. Details of Quarters as follows:

(a) Quarter 1 - From 01 May to 31 Jul
(b) Quarter 2 - From 01 Aug to 31 Oct
(c) Quarter 3 - From 01 Nov to 31 Jan
(d) Quarter 4 - From 01 Feb to 30 Apr

- 2. During every quarter the Empanelled contractor shall bound to attend breakdown service of Air- Conditioners, if any within a period of 24 hours of intimation through telephone/mobile phone by the Branch Mangers or any other person authorized.
- 3. Charges in connection with the replacement of spare parts and compressor shall be paid extra on production of valid invoice through which the purchase is effected.
- 4. Before performing the routine/breakdown service, the Empanelled Contractor should take due permission from the concerned Branch Manager or any other authorised person and demonstrate the working of the Air-Conditioning units to such person after the servicing.
- 5. While performing the routine / breakdown service, the Empanelled contractor shall take due consent from the Branch Manager or any other authorized person before making any replacement of parts/major systems.
- 6. Up on completion of the routine service or breakdown service the Empanelled Contractor shall enter the details of work done, parts replaced if any and specific remarks if any with date in the service report and get it endorsed by the Branch Manager or any other authorised person.
- 7. The contract amount for every quarter will be paid to the Empanelled Contractor after the completion of every quarter.
- 8. During the routine/breakdown service of Air-Conditioners, the Empanelled Contractor should take sufficient measures for the safety of the technicians and workers engaged by him in such maintenance activities and the Empanelled Contractor himself only shall be responsible for any loss or damage caused to him or the people deputed by him in this regard.

- 9. During the course of service of the Air-Conditioners any damages or losses that may occur to the Air-Conditioning units or any other equipment or assets of the Bank due to careless/improper handling or faulty/improper adjustments, the Empanelled Contractor shall be responsible for the same and he will be bound to compensate for the losses suffered to the Bank in that respect.
- 10. Continuation of the contract depends upon performance satisfactory to the Branch Manager / Person In-Charge. The contract amount will be paid upon satisfactory execution of the contract.
- 11. The Price Bid should contain all relevant rates and charges (Service charge / installation Charge) and the rates should be quoted in Indian Rupees only.
- 12. Cost economics of the bids will be decided on the Basis of Total Cost of Equipment/cost of components having low MTBF/ services as enumerated in the enclosed Application cum Bid Form.
- 13. <u>Vendors from Tamilnadu only participate in the bidding process, others state vendors participating in the bid need to demonstrate presence of branch office in the district of Thanjavur or Ariyalur.</u> Preference will be given to vendors having Offices in Thanjavur and Ariyalur Districts. Other adjacent districts Trichy, Mayiladuthurai, Nagapattinam and Thiruvarur can apply, their selection subject availability of local vendors.
- 14. Rates of equipment/services will be arrived individually based on L1 rates of bids received, all the bidders will be called to match rates arrived at. Rate contract shall be awarded subjected to acceptance of rates arrived at by bidding process.
- 15. Branches/Offices will be allotted to vendors by Zonal Office Kumbakonam. Performance of the Empanelled Vendor will be reviewed Half yearly basis through feedback from Branch Managers and Heads of offices in the zone.
- 16. If the Empanelled Contractor fails to comply with or violate any terms and conditions agreed up on, he/she will be de-empanelled.
