- 3. Please note that this call letter does not constitute an offer of engagement nor does it represent any commitment on part of Organization to select you to any post.
- 4. The Photograph and Biometrics/IRIS of the candidate will be captured on the date of interview and the same will be verified at any later stage as per the discretion of the Bank. Decision of the IRIS/Biometrics data verification authority with regard to its status (matched or mismatched) shall be final and binding upon the candidates. Refusal to participate in the process of IRIS / Biometric Data capture/verification on any occasion will lead to cancellation of candidature.
- 5. Candidates are also advised not to change their appearance till the process is completed. Failure to produce the same photograph at various stages of the process or doubt about identity at any stage could lead to disqualification.
- 6. Please note that, the admission to Interview is provisional only and if it is found at any later stage that you do not conform to the eligibility norms, your candidature will be summarily rejected. Please note that in case at any stage of selection, and even after engagement if it comes to the notice of Bank that you do not/you did not possess the requisite qualification and/or you did not fulfill the eligibility criteria as given in the advertisement, your candidature is liable for rejection.
