**Mandatory conditions / requirements**

The offers are invited in two-bid system (i.e. Technical Bid & Financial bid). Interested parties may obtain the prescribed format of technical bid and financial bid from Indian Bank’s Zonal Office sambalpur, Shyam Arcade, Khetrarajpur, sambalpur (Odisha) between 10.00 AM to 5.00 PM from Monday to Saturday (except second/fourth Saturday and holiday) up to 01:00 PM on last date of tender submission or may download the same from Bank’s website (<https://www.indianbank.in/tenders/>). The tender form are available at cost of Rs 500/- (non refundable) by Demand Draft favouring Indian Bank payable at Sambalpur at above mentioned address or the same may be downloaded from Bank’s website (the tender form downloaded from website should attached with Rs 500/- demand draft favouring Indian Bank payable at Sambalpur). The Earnest Money Deposit (EMD) of Rs 20,000/- (Rs Twenty Thousand only), refundable (without interest) in form of demand draft favouring Indian Bank payable at Sambalpur and valid for a period of 60 days, should be submitted along with the Technical Bid of the vendors. Bids not accompanied by EMD or without proper validity will be summarily rejected.

**GENERAL INSTRUCTIONS FOR BIDDERS**

**1. SCOPE OF THE WORK: Vendor(s) will be empanelled for the under mentioned works: -**

(a) Rate contract for Supply/ Installation of Integrated Alarm System & its components/ spares/ accessories as well as existing Security Alarm System and Fire Alarm System at Branches and offices of Indian Bank, in **Sambalpur Zone (branches spread across Odisha State)**, as and when required basis for a period of **one year from date of contract**, with an option to continue for further 1+1 years on mutual consent of the Bank and the vendor.

(b) **Comprehensive Preventive Maintenance of newly supplied integrated Alarm System on regular basis.** Each branches/ offices under Sambalpur zone where new alarm system will be installed must be mandatorily visited by the AMC provider once in a quarter and subsequent visit as and when required basis for breakdown/corrective maintenance. No additional charges will be paid for subsequent visits. The term of AMC contract will be for a period of **one year** from date of expiry of warranty of the new alarm system, **extendable further for 1+1+1+1 years**. However, Bank may ask the vendor to provide AMC service for alarm system supplied by them upto 5 years from this empanelment and rate contract at the quoted AMC rate.

(b) **Preventive Maintenance of Existing Alarm System on regular basis.** Each branches/ offices under Sambalpur zone where alarm system are already installed must be mandatorily visited by the AMC provider once in a quarter and subsequent visit as and when required basis for corrective maintenance. No additional charges will be paid for subsequent visits. The term of AMC contract will be for a period of one year from date of commencement of the contract, **extendable further for 1+1 years**. The same may be extended for another 1+1 year if both parties agree.

After satisfactorily completion of the contract, if both parties are willing to continue the contract in the existing terms and conditions, the contract may be extended for subsequent year(s).

**Indian Bank Zonal Office Sambalpur reserves the right to terminate the contract on 30 days' notice without assigning any reason.**

**2. Empanelment of Vendor(s)**

In respect to empanelment of Vendor(s)/Firm(s)/Supplier(s) the following shall be applied.

(a) For this purpose Vendors/Firms/Suppliers shall submit proof of documents along with the Tender, if Vendors/Firms/Suppliers are not submitting documentary proof and / or not conforming to any of parameters will not be shortlisted.

(b) The offer will be in two parts, **Technical Bid** and **Price or Commercial Bid**. Both the parts should be submitted in separate sealed covers duly superscripted "**TECHNICAL BID FOR SUPPLY, INSTALLATION AND MAINTENANCE OF INTEGRATED ALARM SYSTEM**" and "**FINANCIAL BIDS FOR SUPPLY, INSTALLATION AND MAINTENANCE OF INTEGRATED ALARM SYSTEM**" respectively and both sealed envelopes should be placed in another sealed envelope superscripted "**OFFER FOR SUPPLY, INSTALLATION AND MAINTENANCE OF INTEGRATED ALARM SYSTEM**". The tenders for Supply, Installation and Maintenance Integrated/ Alarm system for branches/Offices/ATMs under "**Sambalpur Zone**" should be dropped/ sent by post at Indian Bank, Zonal Office, Sambalpur to apply for said Tender.

3. **Splitting of Order:**

The Bank can split the order amongst the vendors who have been identified as L1 vendor and L2 vendor. However, where the work is less and if Bank finds that it will be suitable to manage the work with only one vendor then the entire work can be allotted to only one vendor at the discretion of the Bank.

4. **TECHNICAL BID OFFER**

The Technical Bid Offer (TO) should be complete in all respects and should contain all information asked for in this document. **It should not contain any price information.**

- (i) Letter of undertaking as per **Annexure-I**
- (ii) Pre qualification as per **Annexure-II**,
- (iii) Technical Specification as per **Annexure – III**
- (iv) General & Technical Information as per **Annexure – VI**
- (v) Product Brochures/ leaflets/ manuals etc.

5. **COMMERCIAL BID**

Commercial Bid should be submitted as per the **Annexure IV**.

6. **EARNEST MONEY DEPOSIT**

Earnest Money Deposit of Rs. 20,000/- (Rupees Twenty Thousand only), in the form of a demand draft/pay order issued by a scheduled commercial Bank favoring Indian Bank, payable at Sambalpur must be submitted along with the Offer. Both Cost of application and EMD to be submitted separately through DEMAND DRAFT only favouring, Indian Bank, payable at Sambalpur respectively, has to be submitted (in physical copy) to Indian Bank Zonal Office, Shyam Arcade, Khetrajpur, Sambalpur Odisha-768003 as on last date and time of submission of bid, in absence of which the bid will be rejected. The Offer, not accompanied with Earnest Money Deposit specified will not be accepted. This amount will be forfeited if, having been selected by the Bank for the job, the Vendors/Firms/Suppliers refuses to accept any contract or having accepted the contract, fails to carry out his obligations mentioned therein. Bank Guarantee In lieu of Earnest Money Deposit will not be accepted. No interest will be payable on the Earnest Money Deposit. The Earnest Money Deposit will be refunded to the unsuccessful Vendors. The Earnest money paid by the successful Vendors will be released only after finalization of Rate contract. The Earnest Money Deposit will be forfeited if the vendor: -

- (a) Withdraws its bid during bid validity period.
- (b) Refuses to honor commercial bid. Bank reserves the right to place order onto vendor based on prices quoted by them.
- (c) Refuses to accept purchase order or having accepted the purchase order, fails to carry out his obligations mentioned therein.
- (d) Refuses to submit bank guarantee on finalization of rate contract. Bid security to successful vendor will be refunded only after successful completion of bid period

7. **PERFORMANCE BANK GUARANTEE**

Before entering into an agreement the selected vender(s) should submit a Bank Guarantee of Rs. **50,000/- (Rupees Fifty Thousand only)** valid for a period of **5 years and 3 Months** from the date of contract, issued by a Public Sector Bank **other than Indian Bank**. Purchaser will have the right to make good the loss from any of the Bank Guarantee given by bidder if given separately, irrespective of the purpose of the guarantee. Format of PBG is kept at **annexure V**.

## 8. VALIDITY PERIOD

The empanelled Vendors/Firms/Suppliers will remain in the empanelled list of the Bank for Indian Bank Sambalpur Zone for three years from the date of empanelment or till the completion of next empanelment period at the Bank's own discretion (whichever is earlier).

- (a) The Annual rate contract and AMC charges will be valid for one year. Based on market rate of products the rate will be reviewed by the bank and if both party agree on that rate then the contract can be extended for further period of one year or more.
- (b) Empanelment will be valid only, if all eligibility criteria mentioned in the advertisement are fulfilled during the entire empanelment period.
- (c) If the service provided by vendor is found to be unsatisfactory or if at any point of time during the empanelment it is found that the information provided by vendor is false or if vendor do not participate in any subsequent RFP or tendering process three times consecutively, the Bank reserves the right to remove the vendor from the empanelment list without giving any notice. Bank's decision in this regard will be final.

## 9. SELECTION PROCESS

Offers will be evaluated in the following stages:

**Stage I** Offers will be evaluated against the stipulated minimum Eligibility Criteria. Offers not complying with the eligibility will be rejected summarily.

**Stage II** Short listing of Vendors/Firms/Suppliers will be based on the evaluation of the technical requirement complied with **live demonstration of alarm system** offered and satisfactory feedback from the reference sites and other clients of the vendors.

**Stage III** The price bids of only short listed vendors (who qualify in both technical bid and demonstration of system) will be opened.

## 10. AVAILABILITY OF SPARES

Vendor should ensure that the Spares for the product offered are available for at least 6 years from the day of installation of equipment. No obsolete equipment should be supplied to the bank.

## 11. PATENTS RIGHTS

The supplier shall indemnify the purchaser against all third party claims of infringement of patent, trademark or industrial design rights arising from use of the Goods, or any part thereof in India. The supplier shall, at their own expense, defend and indemnify the Bank against all third party claims or infringement of intellectual Property Right, including Patent, trademark, copyright, trade secret or industrial design rights arising from use of the products or any part thereof in India or abroad. The supplier shall expeditiously extinguish any such claims and shall have full rights to defend it there from. If the Bank is required to pay compensation to a third party resulting from such infringement, the supplier shall be fully responsible for, including all expenses and court and legal fees. The Bank will give notice to the Supplier of any such claim without delay, provide reasonable assistance to the Supplier in disposing of the claim, and shall at no time admit to any liability for or express any intent to settle the claim. The Supplier shall grant to the bank a fully paid-up, irrevocable, non-exclusive license throughout the territory of India or abroad to access, replicate and use software (and other software items) if any, provided by the supplier, including-all inventions, designs and marks embodied therein in perpetuity.

## 12. TERMINATION FOR INSOLVENCY

The Bank may at any time terminate the Contract by giving written notice to the Bidder, if the Bidder becomes bankrupt or otherwise insolvent.

13. **LIABILITY**

Vendor's aggregate liability under the contract shall apply to third party claims for bodily injury/electric shock (including death) and damage to real property (due to malfunction of equipment) and tangible personal property caused by vendor's gross negligence/lapse or due to below standard equipments used by Vendor. The Vendor shall be liable for any indirect, consequential, or special damages due to malfunction of the security equipments under the agreement / purchase order.

14. **WARRANTY**

The offer must include on-site warranty from the date of installation and commissioning of the equipments however there should not be any additional cost for the warranty period. "No AMC" charge will be admissible in first year of warranty however quarterly service visit is mandatory during the period.

15. **PENALTY**

The service provider should maintain the system in functional condition. In case of any defect or breakdown in the system, the same should be rectified within 48 hours of intimation of the defect through phone call/ email/ SMS/ whatsapp message. If the defect is not rectified within 48 hours, penalty will be imposed as mentioned below on the service provider:

a.	Alarm system is non functional for more than 48 hours to 72 hours	25% of AMC quarterly AMC charge for the non functional system
b.	Alarm system is non functional for more than 48 hours to 96 hours	50% of AMC quarterly AMC charge for the non functional system
c.	Alarm system is non functional for more than 96 hours to 10 days	100% of AMC quarterly AMC charge for the non functional system
d.	Alarm system is non functional for more than 10 days	200% of AMC quarterly AMC charge for the non functional system
e.	Alarm system is non functional for more than one month	400% of AMC quarterly AMC charge for the non functional system
f.	Non submission of visit report of quarterly visit or non visiting of branch for quarterly mandatory visit.	Additional 50% of quarterly AMC charge of one alarm system.

16. **FORCE MAJEURE**

Notwithstanding the above provisions, the Successful bidder shall not be liable for penalty or termination for default, if and to the extent that its delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure. For purposes of this clause, "Force Majeure" means an event beyond the control of the Bidder and not involving the Bidder's fault or negligence and not foreseeable. Such events may include, but are not restricted to, wars or revolutions and epidemics. If a Force Majeure situation arises, the Bidder shall promptly notify the Bank in writing of such condition and the cause thereof. Unless otherwise directed by the Bank in writing, the Bidder shall continue to perform its obligations under the Contract as far as is reasonably practical, and shall seek all reasonable alternative means of performance not prevented by the "Force Majeure" event.

17. **NUISANCE:**

The Vendor shall not at any time do cause or permit anyone to or cause any nuisance on the site or do anything which shall cause unnecessary disturbance of inconvenience to the Bank, Owners, Tenants or occupier of other properties near the site and to the customers/public generally.

18. **GOVERNING LAW AND DISPUTES**

The provisions of this tender shall always be subject to Government Notifications, any rules/guidelines that may be in force from time to time. All disputes or differences whatsoever arising between the parties out of or in relation to the construction, meaning and operation or effect of these Tender Documents or breach thereof shall be settled amicably. If, however the parties are not able to solve them amicably, the same shall be settled by arbitration in accordance with the provisions of "Arbitration and Conciliation Act-1996" or any statutory modifications or re-enactments thereof and the rules made there under and for the time being in force, shall apply to the arbitration proceedings. The arbitrator shall be appointed with the mutual consent of both the parties. However, there is a provision of appeal if either party is not satisfied with the arbitration award. During the arbitration proceedings the Vendor shall continue to work under the Contract unless otherwise directed in writing by the Bank or unless the matter is such that the work cannot possibly be continued until the decision of the arbitrator is obtained.

19. **NO COMMITMENT TO ACCEPT LOWEST OR ANY TENDER**

The Bank shall be under no obligation to accept the lowest or any other offer received in response to this notice and shall be entitled to reject any or all offers without assigning any reasons whatsoever. The bank will have right to opt for any new technology optimum for the Banks usage.

20. **PAYMENT TERMS**

No advance amount will be paid to vendor. Payment will be released by the respective branches only on completion of work upon submission of satisfactory installation report duly endorsed by the Branch. AMC charges will be paid by the branches on quarterly basis. No AMC will be paid by the branch if service rendered is not as per satisfaction of respective branch manager in terms of prescribed norms of AMC.
