#### EMPANELMENT OF SECURITY SERVICE PROVIDERS

Indian Bank Management Academy for Growth and Excellence (IMAGE) intend to engage a Security Services provider for 2 years from January 01, 2013 to December 31, 2014 for providing round the clock security and fire and rescue service.

The scope of the work consists of engaging 6 security guards round the clock. That is to say, at any point of time, 6 security guards shall be present and be on duty at IMAGE .In addition to the security guards, there shall be a supervisor. The security guards shall have training and experience in operating fire fighting equipments in an emergency. All Security Guards shall be below 50 years of age.

The Security Services provider should satisfy the following:

- a. Should be in the business for the last five years.
- b. Should be willing to make a Security Deposit of Rs. 50000/- with IMAGE during the contract period.
- c. Should have effective infrastructure for the training of the Guards.
- d. Should have credible supervisory infrastructure and network.
- e. Should have a Certificate of Registration issued by the Registrar of Companies or Registrar of Firms or letter of Proprietorship.
- f. Should have Income Tax Clearance Certificate (latest) and PAN.
- g. Should have Audited Balance Sheet (last 3 years).
- h. Should have Registration under Shops & Establishment Act and Certificate from ESI Corporation (latest).
- i. Should have Certificate from EPF Organisation- EPF & Misc.Provision Act-1952 (latest).
- j. Should be registered with the Govt. under Contract Labour (Regulation & Abolition) Act 1970.
- k. Should have Registration with appropriate authority for Service Tax.
- I. Should have Documents providing compliance of Minimum Wages Act, 1948 and Central Rules (latest).

Due weightage shall be given to the following:

- a. Concerns sponsored by Director General of Resettlement, Ministry of Defence, R .K. Puram, New Delhi.
- b. Concerns providing services to Public Sector Banks and Public Sector undertakings.

Applications without certified copies or self attested photocopies of documents, Certificates, sales tax/income tax returns/audited balance sheets etc. in support of fulfilling pre-qualification criteria as above will not be considered.
